Minutes of Special Called Session Anniston City Board of Education Tuesday, June 9, 2020-2:00 p.m.

The Anniston City Board of Education met in special session on Tuesday, June 9, 2020, in the Board Room of the Central Office, 4804 McClellan Boulevard.
