A. Reduction in Force (RIF) General Criteria

Mrs. Tieasha Rasheed, Accounting/HR Coordinator presented the General Criteria for the Reduction in Force (RIF). Mrs. Rasheed outlined the following criteria for the reduction inforce.:

RIF(ReductionInForce)

Objectives:

- To align the district with state earned units
- To achieve at least a one-month reserved fund balance, which is required by the State Department of Education (SDE) of ~\$1.5M

General Criteria:

- Alignment of contract days with positions
- Elimination of support personnel
- Elimination of school programs, based on student participation
- Relocation due to the closing of Tenth Street Elementary
- Staff Redundancies & Streamlining of Positions

The board members asked several questions concerning the criteria. All questions were answered by Mrs. Rasheed and Superintendent Dr. Hill. The board thanked Mrs. Rasheed for the presentation.
